PDPA NOTICE

- 1. This PDPA Notice ("Notice") outlines how HLL Group of the Companies, its related corporations, associates, affiliates and joint development companies as well as their representatives (collectively, "HLL Group of the Companies") collect, use, disclose and process your Personal Data in respect of transactions with HLL Group of the Companies.
- 2. For the purpose of this Notice, the terms "we", "our" and "us" shall refer to any company or representative within HLL Group of the Companies and the terms "you" and "your" shall refer to yourself and/or such other persons or companies represented by you of which you are providing Personal Data.
- 3. In this Notice "Personal Data" includes all data defined within the Personal Data Protection Act 2010 (as amended from time to time).
- 4. Such Personal Data which you may provide or make available to HLL Group of the Companies include information concerning your personal details (such as name, identity card number, passport number, date of birth, age, gender, race, nationality), contact details and any other relevant information that you had disclosed to HLL Group of the Companies as may be updated from time to time.
- 5. In the course of your dealings with HLL Group of the Companies, you may have furnished your Personal Data to HLL Group of the Companies and in doing so you agree and consent to HLL Group of the Companies collecting, using, disclosing and processing your Personal Data.
- 6. In the event you furnish or make available to HLL Group of the Companies any Personal Data relating to a third party eg information of spouse, children, parents, directors, shareholders and/or guarantors (collectively the "Relevant Persons") you represent that you have obtained the consent of the Relevant Persons to provide HLL Group of the Companies with their Personal Data and for HLL Group of the Companies to collect, use, disclose and process their Personal Data for the respective purposes.
- 7. HLL Group of the Companies collects your Personal Data in various ways, in printed or electronic forms through digital and mobile platforms, such as:
 - i. when you register or update an online profile or when you complete or update your information with HLL Group of the Companies;
 - ii. when you submit forms and/or documents to HLL Group of the Companies relating to any of our products and/or services as well as products and/or services by third party service providers;
 - iii. when you enter into any transactions with HLL Group of the Companies;
 - iv. when you make payment related to any transactions with HLL Group of the Companies;
 - v. when you interact with HLL Group of the Companies' staff;
 - vi. from your personalised preference through the use of HLL Group of the Companies' website;
 - vii. when you participate in HLL Group of the Companies' contests, events, market research and surveys;
 - viii. when you submit a job application to HLL Group of the Companies; and
 - ix. from information obtained independently by HLL Group of the Companies from other lawful sources.
- 8. HLL Group of the Companies may collect, use, disclose or process your Personal Data for the following purposes:
 - i. considering and processing your application for and providing you with products and/or services of HLL Group of the Companies as well as products and/or services by third party service providers provided through HLL Group of the Companies;
 - ii. facilitating, implementing and/or formalising any transaction with HLL Group of the Companies;
 - iii. processing any payments related to any transaction with HLL Group of the Companies;
 - iv. responding to queries, requests and/or complaints;
 - v. facilitating HLL Group of the Companies' customers loyalty programmes;
 - vi. updating your Personal Data;
 - vii. facilitating your participation in HLL Group of the Companies' contests and events;
 - viii. conducting market research and surveys with the aim of improving HLL Group of the Companies' products and/or services;
 - ix. sending you marketing, advertising and promotional information about other products/services that HLL Group of the Companies, its business partners or third-party providers may be offering ("Marketing Information"), by way of postal mail to your address(es) and/or electronic transmission to your email address(es), text messages (SMS/MMS), telephone calls and/or other phone-based messaging to your telephone number(s);
 - x. conducting credit/trade checks and other background checks on you and where applicable, any Relevant Persons with any registered credit reporting agency at any time for the purpose of processing a transaction with HLL Group of the Companies or for as long as any dues remain unpaid and outstanding with HLL Group of the Companies;

- xi. for the purpose of credit evaluation, review or reporting and carrying out debt-collection or assisting other institutions to do so:
- xii. prevention and detection of crime including without limitation to money laundering, terrorism and fraud prevention, detection and prosecution;
- xiii. required by laws, rules, regulations, by-laws, order, guidelines and/or directives;
- xiv. enforcing HLL Group of the Companies' legal rights and/or obtaining legal advice;
- xv. facilitating business transactions which may include mergers, acquisitions or asset sales;
- xvi. compliance with internal policies and procedures including without limitation to risk management, product planning, insurance, audit and administrative purposes;
- xvii. for all ancillary purposes relating to the provision of facilities including the provision of computer, telecommunications and technology services;
- xviii. human resource applications;
- xix. and/or any other incidental purpose relating to any of the above.

Where you have consented to receiving Marketing Information and/or sharing your Personal Data with third parties for the purpose of Marketing Information, you may opt-out of receiving such Marketing Information or sharing of your Personal Data with third parties for the aforesaid purpose at any time by contacting HLL Group of the Companies at the details provided in Section 13.

- 9. In the event where Personal Data is requested by HLL Group of the Companies, you have an option not to provide additional information requested other than the information which is indicated as necessary to facilitate the commercial transaction. If insufficient Personal Data is provided or your consent or the consent of any Relevant Person given herein is withdrawn, HLL Group of the Companies will not be able to provide you with its products and services and/or fulfil any of your request to HLL Group of the Companies for any of the purposes as set out in Section 8
- 10. For the purposes as set out in Section 8, your Personal Data may/will be disclosed to the following parties:
 - i. any company or representative within HLL Group of the Companies;
 - ii. HLL Group of the Companies' third-party service providers or agents (including without limitation auditors, lawyers, consultants, insurers, adjusters and utility companies);
 - iii. any registered credit reporting agencies under Credit Reporting Agency Act 2010;
 - iv. HLL Group of the Companies' business partner, investor, assignee or transferee to facilitate business asset transactions (including without limitation to any merger, acquisition or asset sale);
 - v. any law enforcement agencies;
 - vi. any governmental authorities or regulatory bodies; and
 - vii. any other party authorised and consented by you.
- 11. HLL Group of the Companies may disclose your Personal Data to any or all of the parties stated above which may be located within or outside of Malaysia or involve sending your Personal Data to a location outside of Malaysia.
- 12. You may request in writing for access to and request for correction of your Personal Data that is inaccurate, incomplete, misleading or not up-to-date subject to a payment of a prescribed fee, any applicable legal restrictions and contractual conditions.

- 14. This Notice may be revised from time to time. Notice of any such revision will be given on our website and/or by such other means of communication deemed suitable by HLL Group of the Companies.
